6.6.19 Planning and Enforcement

- a) **SDNP/18/05506/FUL** SDNP/18/05746/LDP Barnet Side Bungalow Lawful Development Certificate for proposed development - Single storey extension to rear. Resolved to OBJECT
- b) SDNP/18/06096/LDP Stoner End, Stoner Hill Road. Lawful development certificate proposed - Increasing the depth of a first floor window to the front elevation by 380mm

- c) SDNP/18/06232/FUL Lambing Shed, Soalwood Lane Conversion of redundant agricultural buildings to a three bedroom dwelling. Resolved to OBJECT
- d) SDNP/18/06306/TCA Carpenter Cottage 12 Hempland Lane Privett Fell one ash tree on roadside boundary. Resolved to OBJECT, on the grounds that there was a lack of information.
- e) SDNP/18/06538/TCA Basing Park House, Norway maple (T1) - Fell. Outgrowing location in close proximity to historic Ha-Ha wall, and roots starting to cause damage. Larch (T2) - Fell. Outgrowing location in close proximity to historic Ha-Ha wall, and roots starting to cause damage. NO OBJECTION

7.6.19 Planning Enforcement

- a) **Land adjacent to Hurst Lane** as there had been no response from Enforcement, the Clerk was asked to email Lesley Wells for an update.

8.6.19 High Speed Broadband Various contractors had been seen in the parish with reports of very recent FTTP connections to properties and FTTC connections. Cllr Oppenheimer's opinion was that properties will gradually be connected, but, by the end of March a marked difference should be noticed.

9.6.19 Road Issues There were reports that the road surface on Stoner Hill Road has become very rough. At the junction of Cockshott and Old Litten Lanes the road surface is badly broken. The Clerk will report these to Highways.

12.6.19 Sports Awards It was agreed that the Parish Council would nominate Lizzie Allen for her fantastic achievements over the last year.

13.6.19 Correspondence

- a) Victoria Primrose from Adventurers had requested to put a wooden log shelter in the top corner of the Memorial Ground. The Councillors agreed to this as long as all hot ash was taken away.

14.6.19 Report from County Councillor Cllr Oppenheimer's Report was circulated prior to the meeting. Cllr Oppenheimer highlighted these points: The Local Government Finance Settlement published on 13th December contained nothing especially surprising. In the Autumn Budget additional funding for adult and children's social care which will provide around £12.9m of additional funding to Hampshire together with £12m for pothole repairs: Cllr Oppenheimer attended the opening of the £30m new by-pass for Bordon and Whitehill. The new road will improve journey times and connectivity.
